## Academy Administrator/Receptionist JOB DESCRIPTION

#### Role Purpose:

The purpose of this role is to provide and effective clerical and reception service to Academy staff, students and visitors

#### Key Accountabilities:

Reporting to the Administration Manager this post holder will be accountable for

- Delivering an effective reception service including answering routine telephone and face to face enquiries; signing in visitors and sorting and distributing internal and external mail.
- Undertaking clerical duties related to the post such as production of letters, reports and other documents as requested using relevant ICT packages such as spreadsheets, databases, Word, internet and SIMS
- Providing general clerical support eg photocopying, filing, faxing, emailing, completing routine forms and responding to routine correspondence
- Maintaining manual and computerised records/returns/management information systems
- Alerting line manager to any concerns through monthly monitoring systems
- Maintaining stock and supplies, cataloguing and distributing as required or as directed
- Attending relevant meetings as required and take notes if requested
- Undertaking other duties appropriate to the grade and role of the post as requested by the line manager
- Responsible for the Health and Safety, security and welfare of self and colleagues in accordance with E-ACT's policies and procedures, reporting all concerns to an appropriate person.
- Responsible for working in accordance with E-ACT's policy relating to the promotion of Equality, Diversity and Inclusivity
