

Senior Lunchtime Organiser JOB DESCRIPTION

Role Purpose:

The purpose of this role is to manage the team of Lunch Time Organisers supervising pupils during the school lunch break, which includes attending to their welfare and domestic needs.

Key Accountabilities:

Reporting to the Lead Pastoral Practitioner, this post holder will be accountable for

- Supervision of pupils immediately before, during and after the mid-day meal. This includes provision for children who bring sandwiches.
- Supervision of hand washing and toileting by pupils as deemed necessary by the Headteacher.
- Supervision of pupils entry and exit from the dining area, including supervision of pupils during any journey or walk to the dining room.
- Supervision of pupils in the playground under the direction of the Lead Pastoral Practitioner.
- Setting up and removal of playground equipment under the direction of the Lead Pastoral Practitioner.
- Taking such steps as necessary when children are sick. Attending to their needs when in distress and reporting the situation to the relevant member of staff.
- To arrange for emergency treatment when required, e.g. calling for a teacher if there has been an accident.
- Vigilant in the playground in recognising potential dangers and approaching unauthorised personnel who enter the academy grounds.
- Undertake an agreed programme of training.
- To carry out other duties relating to lunchtime supervision as requested by the Headteacher, Deputy Head or Senior Leadership Team.

<u>Culture</u>

- Responsible for the Health and Safety, security and welfare of self and colleagues in accordance with E-ACT's policies and procedures, reporting all concerns to an appropriate person.
- Responsible for working in accordance with E-ACT's policy relating to the promotion of Equality, Diversity and Inclusivity
