#### Role Purpose:

The purpose of this role is to provide technical support to teaching staff and ensure a safe and clean working environment to facilitate high-quality teaching within the faculty.

#### **Key Accountabilities:**

Reporting to the Head of Faculty, this post holder will

- Assist teachers with preparation of resources and equipment for lesson delivery on a daily basis
- Assist in lessons as required during practical sessions
- Develop apparatus and equipment for use in practical sessions and provide technical advice and assistance to teaching staff as required regarding resources for practical work and demonstrations
- Carry out practical demonstrations in the classroom as required
- Construct and modify apparatus as required, at the request of teachers in the faculty
- Retrieve, clear and clean equipment, including disposal of waste material in line with established guidelines
- Audit stock, keep records, order and check deliveries of materials in consultation with the Head of Faculty
- Manage equipment, including checking and storing appropriately
- Maintain equipment daily to ensure safe use and repair and replace when necessary
- Provide support and guidance to teaching staff on resources required including researching options and their budget implications
- Ensure and promote the maintenance of a healthy and safe working environment
- Ensure used materials are treated and disposed of safely
- Carry out daily Health and Safety checks across the department
