#### MAIN TASKS AND RESPONSIBILITIES:

- Preparation of exam rooms and relevant equipment
- Liaison on access arrangements and seating candidates
- Attendance registers
- Invigilating exams as working supervisor
- Co-ordination of invigilation arrangements and dealing with issues arising from exams
- Administration of exam materials
- Keeping up to date with changes to exam arrangements
- Perform other reasonable duties within scope of skills as directed by exams officer
- To attend relevant training sessions
- To support with the printing and organising of candidate cards
- To support with displaying seating plans outside the exam rooms]
- To help organise the other invigilators and direct them to other exams where necessary
