# Teaching Assistant Level 2 JOB DESCRIPTION



#### **Role Purpose:**

The purpose of this role is to work with teachers to support teaching and learning, providing general and specific assistance to pupils and staff under the direction, guidance and direct supervision of the classroom teacher. Work may be carried out in the classroom or outside the main teaching area.

#### **Key Accountabilities:**

Reporting to the Senco, Phase Lead, or Headteacher, this post holder will be accountable for

#### Support for pupils

- Work with either individuals or small groups of pupils in or outside the classroom ensuring their safety and access to learning activities.
- Supervise and provide particular support for pupils, including those with special needs, ensuring their safety and access to learning activities
- Support pupils to understand instructions and support independent learning
- Assist with the implementation of Individual Education/Behaviour plans and Personal Care programs under the supervision and guidance of teaching staff
- Establish constructive relationships with pupils and interact with them according to individual needs
- Promote the inclusion and acceptance of all players
- Encourage pupils to interact with others and engage in activities led by the teacher
- Provide feedback to pupils in relation to progress and achievement in agreement with the teacher
- With appropriate training, to meet the specific medical needs of identified pupil(s) during the school day

#### Support for the teacher

- Create and maintain a purposeful, orderly and supportive environment in accordance with lesson plans and assist with the display of pupils' work
- Use strategies, under the supervision and guidance of the teacher, to support pupils to achieve learning goals
- Monitor pupils' responses to learning activities and accurately record achievement and progress as directed

- Provide detailed and regular feedback to teachers on pupils' achievement, progress, and behaviour
- Promote good pupil behaviour, dealing promptly with conflict and incidents in line with the established policy and encourage pupils to take responsibility for their own behaviour
- Establish constructive relationships with parents/carers
- Administer routine tests, invigilate exams and undertake routine marking of pupils' work

# Support for the curriculum

- Undertake structured and agreed learning activities/teaching programmes under the supervision and guidance of teaching staff
- Undertake programmes linked to local and national learning strategies e.g., literacy, numeracy, early years recording achievement and progress and feeding back to the teacher
- Support the use of ICT in learning activities and develop pupils' competence and independence in its use
- Prepare and clear up the learning environment and resources, including photocopying, filing and the display and presentation of pupils' work and contribute to maintaining a safe environment
