### **Role Purpose:**

- Support the Head of Department with the day-to-day leadership for the development and management of teaching within your area
- Develop and monitor schemes of work for your area across the academy in liaison with your Head of Department and ensure the successful implementation which meets curriculum requirements and differentiated to reflect student needs.
- Contribute to the planning and delivery of continuous professional development and training related to your area.
- Monitor and evaluate pupil progress and achievement against targets in your area.
- Liaise with colleagues to identify and co-ordinate pupil support and intervention strategies
- Assist with the development of innovative, creative approaches to learning and to develop cross-curricular skills such as ICT, numeracy & literacy effectively in the delivery of teaching and learning in your area.
- Assist with the implementation of national and local strategies for raising attainment of students in your subject, in accordance with the Academy improvement plan.

- To assist in the raising attainment for students in your subject area.
- To assist in the monitoring and evaluation of pupil progress and achievement against targets
- To assist in the identification of any areas of pupil under-achievement within the department and identify specific interventions as a result
- To work within the Academy Learning Leadership team and contribute to the development and implementation of raising achievement and attainment within the Academy.
